

# **Guidelines for Submission of Papers to the Journal of Criminal Investigation and Criminology**

## **Length of Contributions**

1. **Original articles**, both original and review scientific articles, should contain from 7,000 to 9,000 words, comprising identical abstracts in Slovenian and English, which are usually from 15 to 20 lines long and should be brief reviews of the article. Empirical articles should be structured according to the IMRAD standard (introduction, methods, research, and discussion).
2. Contributions in sections **Notes, From Practice or From Elsewhere** should not exceed 20,000 words.
3. **Notes, Reviews, and Book reviews** may not exceed 3,000 words.
4. The length of **other contributions** should be agreed upon with the Editors-in-chief.

## **Guidelines for Writing Articles**

All articles must be prepared in accordance with the house style of the Journal of Criminology and Criminology. General instructions for writing papers are given below, a practical example of writing can be found in the **Sample Paper** document.

1. Headings and subheadings.
  - a. Title of the paper – Times New Roman, font size 14, bold, spacing 1.5.
  - b. Level 1 heading (**1 Heading**) – Times New Roman, font size 12, bold, spacing 1.5, justified alignment; before the heading number of the section.
  - c. Level 2 heading (**1.1 Heading**) – Times New Roman, font size 12, bold, spacing 1.5, justified alignment; before the heading number of the section and the number of subsection.
  - d. Level 3 heading (**1.1.1 Heading**) – Times New Roman, font size 12, bold and italic, spacing 1.5, justified alignment; before the heading numbers of the section and subsection and the number of subsection of the second order.
2. Main text – Times New Roman, font size 12, bold, spacing 1.5, justified alignment.
3. Footnotes – Times New Roman, font size 10, spacing 1, justified alignment (the style of Journal of Criminal Investigation and Criminology does not provide for the use of endnotes).
4. Tables (the title and source of the table are placed above the table).

- a. Title of the table (**Table 1: Title of the table**) – Times New Roman, font size 12, bold, spacing 1.5, justified alignment; before the title number of the table.
  - b. Source of the table (in brackets behind the title of the table) – Times New Roman, font size 12, bold, spacing 1.5, justified alignment.
  - c. Text in the table – Times New Roman, font size 10, spacing 1, center alignment.
5. Graphs (the title and source of the graph are placed below the graph).
- a. Title of the graph (**Graph 1: Title of the graph**) – Times New Roman, font size 12, bold, spacing 1.5, center alignment; before the title number of the graph.
  - b. Source of the graph (in brackets behind the title of the graph) – Times New Roman, font size 12, bold, spacing 1.5, center alignment.
6. Figures (the title and source of the figure are placed below the figure).
- a. Title of the graph (**Figure 1: Title of the figure**) – Times New Roman, font size 12, bold, spacing 1.5, center alignment; before the title number of the figure.
  - b. Source of the figure (in brackets behind the title of the figure) – Times New Roman, font size 12, bold, spacing 1.5, center alignment.
7. Literature – Times New Roman, font size 12, bold, spacing 1.5, justified alignment.
- a. References used are listed alphabetically and numbered – Times New Roman, font size 12, spacing 1.5, justified alignment.
  - b. In cases where several works by the same author are cited in the same year, the letters of the alphabet (a, b, c) are also given next to the year.

## Formatting guidelines

All cited sources must be included in the reference list and vice versa – all references must be cited at least once in the text. Citation in the text and references must be in accordance with the style of the APA Manual, 7<sup>th</sup> Edition.
